



**General Information:** The T.I.P. Championships will take place during the New Vocations Charity Thoroughbred Show on Sunday September 10, 2017 in the Rolex Arena at the Kentucky Horse Park. In addition to this declaration form, entries must be made through the New Vocations Charity Thoroughbred Show. Management reserves the right to limit, combine split or cancel divisions. All Rules of the New Vocations Charity Thoroughbred Show will apply.

**Eligibility/Qualification:** To qualify for the Championships, a Thoroughbred must participate at a show offering T.I.P. High Point Awards, Classes or Divisions in the applicable discipline between **September 1, 2016 and July 31, 2017** or participate in the 2016 T.I.P. Performance Awards in the applicable discipline. All Thoroughbreds must have a T.I.P. Number to qualify. Each horse may only be entered in one (1) Championship Division at or above the lowest height jumped during the Championship year. Cross entering is not permitted for the same horse/rider combination. For purposes of eligibility, a "Thoroughbred" is defined as any horse that has been registered with The Jockey Club or a foreign Thoroughbred stud book recognized by TJC.

**Instructions:** Fill out this form for each Thoroughbred (and if applicable, a hardship statement\*) completely and mail to The Jockey Club Thoroughbred Incentive Program.
