2018 T.I.P. CHAMPIONSHIPS DRESSAGE/WESTERN DRESSAGE HORSE DECLARATION FORM

Eligibility/Qualification: To qualify for the Championships, a Thoroughbred must participate at a show offering T.I.P. High Point Awards, Classes or Divisions in the applicable discipline between **August 1, 2017 and July 31, 2018** or participate in the 2017 T.I.P. Performance Awards in the applicable discipline. Horses can be shown in any dressage class or division at the show offering T.I.P. awards. Horses shown at a horse trial or combined test may also qualify for the Championships through their dressage phase. All Thoroughbreds must have a T.I.P. Number to qualify. Each horse may declared for multiple divisions at or above the lowest level competed during the Championship year; HOWEVER, each horse may only be entered in one (1) Championship Division at or above the lowest level competed during the Championship year. Cross entering is not permitted across any Championship divisions (including other disciplines). For purposes of eligibility, a "Thoroughbred" is defined as any horse that has been registered with The Jockey Club or a foreign Thoroughbred stud book recognized by TJC.

Instructions: Fill out this form completely for each Thoroughbred (and if applicable, a hardship statement*) and mail to The Jockey Club Thoroughbred Incentive Program.
