

2020 T.I.P. CHAMPIONSHIPS HORSE DECLARATION FORM

Only use this form if you qualified for the T.I.P. Championships.

If you need to submit a Hardship Request, please use the 2020 T.I.P. Championships Hardship Declaration Form.

Eligibility/Qualification: For purposes of eligibility, a "Thoroughbred" is defined as any horse that has been registered with The Jockey Club or a foreign Thoroughbred stud book recognized by TJC. To qualify for the Championships, a Thoroughbred must participate at a show offering T.I.P. High Point Awards, Classes or Divisions in the applicable discipline between August 1, 2019 and July 31, 2020 or participate in the 2019 T.I.P. Performance Awards in the applicable discipline. Horses can be shown in any division in the discipline at the show offering T.I.P. awards. Horses shown at a horse trial or combined test may also qualify for the September Championships through their show jumping or dressage phase. All Thoroughbreds must have a T.I.P. Number to qualify. Each horse may be declared for multiple divisions at or above the lowest height jumped during the Championship year.

Entering: Each horse may only be entered in <u>one (1)</u> Championship Division at the September Hunter/Jumper/Pleasure Show and <u>one (1)</u> Championship Division at the October Dressage/Western Dressage/CT Show. <u>Cross entering at each individual show is not permitted for T.I.P. Championships.</u> Horses may be declared for more than one division but must enter only one division at time of entry for each show. Management reserves the right to limit, combine, split or cancel divisions. You can use one form to declare for both shows if you have automatically qualified as described above. However, if you are declaring for one show via a hardship request, you must also submit a Hardship Declaration Form must be received by <u>July 15</u>.

Instructions: Fill out this form <u>completely</u> for each Thoroughbred and mail to The Jockey Club Thoroughbred Incentive Program.
