# Registration for participation in USDF All-Breeds Awards

**Only use this form if you are participating in USDF All-Breeds for The Jockey Club**

**Eligibility:** For purposes of eligibility, a "Thoroughbred" is defined as any horse that has been registered with The Jockey Club or a foreign Thoroughbred stud book recognized by TJC. In order to prove eligibility, you must provide one of the following:

- a) The Jockey Club Certificate of Foal Registration; or
- b) The Jockey Club Digital Certificate of Foal Registration (horses born in 2018 or later only); or
- c) A T.I.P. eligibility letter. [*this can be requested with this form – see instructions below*]

**How to participate:** To participate in USDF All-Breeds, you must:

- a) Complete this form, submit the required photograph(s) and pay the applicable fees on an annual basis; and
- b) Obtain a T.I.P. Number for your horse; and
- c) Declare your horse with the USDF All-Breeds Award Program on the All-Breeds Awards Declaration Form available at [www.usdf.org/docs/awards/all-breeds/DeclarationForm.pdf](http://www.usdf.org/docs/awards/all-breeds/DeclarationForm.pdf).

**Instructions:** Fill out this form for each Thoroughbred and mail with all applicable attachments and fees to: **The Jockey Club T.I.P., 821 Corporate Dr., Lexington, KY 40503.** Checks should be made out to The Jockey Club.

**Fees:** \$35 per year to register with The Jockey Club for USDF All-Breeds

- If Yes – Complete the horse information below and submit (i) a copy of the T.I.P. eligibility letter, (ii) a photograph of your horse clearly showing the markings and (iii) the \$35 fee.

**If you do not have a Certificate of Foal Registration or T.I.P. eligibility letter:**

- If you know your horse's registered name, submit (i) at least four photos of the whole horse (front, back and each side without blankets, wraps or boots), photos of the tattoo, and if the horse has no white markings, a photo of the face showing the cowlick and photos of the night eyes (chestnuts) on the legs; (ii) complete the horse information below; and (iii) submit the \$35 fee. If we can verify the horse is a horse we registered, we will issue an eligibility letter for purposes of TIP. If we cannot, DNA typing may be required for an additional fee.
- If you do not know your horse's registered name, submit (i) at least four photos of the whole horse (front, back and each side without blankets, wraps or boots), photos of the tattoo, and if the horse has no white markings, a photo of the face showing the cowlick and photos of the night eyes (chestnuts) on the legs; (ii) complete the horse information below, (iii) write any additional information about the horse (possible names, where it came from, etc.) on the back of this form and (iv) submit a \$115 fee (\$35 for the All-Breeds Program and \$80 for DNA typing). If we can verify the horse is a horse we registered, we will issue an eligibility letter for purposes of TIP. Please note, DNA typing is only available for horses born in 2001 or later.
